Graffiti Design (Pty) Ltd Terms and Conditions

- 1. Graffiti Design (PTY) Ltd offers 30 day account facilities.
- 2. A 70% deposit is required for non- account qualifying customers, upon acceptance of the quote, before production can start. Full payment must be made before vehicle collection for COD customers.
- 3. Design fees are determined by the complexity and type of design required if the 3 iterations are exceeded.
- 4. Production lead time is approximately 5-7 working days from final artwork sign off.
- 5. Quotes are valid for 7 days from the quoted date.
- 6. Graffiti Design (Pty) Ltd is not liable for any vehicle damage during vinyl application or removal in the following circumstances:
 - Vehicle was resprayed due to an accident before branding.
 - Vehicle is older than 3 years at the time of branding.
 - Paint is lifting on parts of the vehicle or on color-coded plastic areas (e.g., bumpers, side beadings).
- 7. A cancellation fee of R1500 applies if a branding slot is missed.
- 8. If vehicle branding is cancelled by the client 48 hours before the scheduled appointment, the application fee will be credited, but any production balance is due in full.
- 9. If cancelled within 48 hours, the full balance is due, and an additional application fee will be charged if rescheduled.
- 10. All decals, materials, and designs remain the property of Graffiti Design (Pty) Ltd until paid for in full. All Designs remains the property of Graffiti and if required at a later stage in open file format a charge will be applicable
- 11. Clients have 7 days after branding to report any vinyl lifting, movement, or bubbling. Graffiti Design (Pty) Ltd will schedule a fix if notified within this period. If not, the warranty is void.

Additional Notes:

- All valuables should be removed from vehicles; Graffiti Design (Pty) Ltd is not responsible for lost personal items.
- Vinyl settling period is 1-2 weeks. Minor movement or bubbles are normal and should resolve in this period and if not Graffiti will do a post heat process to correct the movement at no cost to the client.

Vehicle Branding Warranty:

- 1. Pigmented or Printed Vinyl with UV Film:
 - o 3 year Warranty
 - 3 years for vinyl adhesion.

Cleaning Instructions:

- Hand wash with hose and standard car shampoo (no waxes or polishes).
- Avoid machine car washes, power hoses, abrasives, waxes, chemicals, or strong detergents.
- Vehicles should be washed weekly (twice a week for commercial vehicles).

Other Terms:

- Graffiti Design (Pty) Ltd is not responsible for any damage to paintwork when removing vinyl from vehicles older than 2 years or on plastic areas (e.g., bumpers, side mirrors).
- Warranty for **Contravision** (window branding) is 6 months, due to inability to varnish. Branding of windows is at the client's own risk.
- Clients may insure their branding through their insurance provider.

Production Process:

- Lead time is 10 working days, subject to design sign-off, stock availability, and receipt of deposit.
- Vehicle photos are required for design confirmation.
- Branding typically takes 1-2 full working days depending on the size of the vehicle. It is recommended to collect the vehicle the following morning for optimal vinyl settling.
