

## **AUTUMN RETAIL COMPETITION TERMS AND CONDITIONS**

### **PROMOTER**

The promoter of this competition is Suzuki Auto South Africa ("the Promoter").

### **COMPETITION DURATION**

The Autumn Retail Competition will run from 3 June 2025 and will close at 23:59 on 31 July 2025. The Promoter reserves the right to amend these dates at any time without prior notice.

### **ELIGIBILITY**

- The competition is open to South African citizens or permanent residents, aged 18 years or older.
- Employees of the Promoter, its affiliates, agencies, and immediate family members are not eligible to enter.
- By entering, participants confirm that they meet the eligibility criteria and agree to these terms and conditions.

### **HOW TO ENTER AND REDEEM A VOUCHER**

To stand a chance to win and redeem a voucher, participants must complete all three of the following steps during the competition period:

1. Play the Drop & Catch game on the official competition platform.
2. Book and complete a test drive at a participating Suzuki dealership.
3. Complete the purchase of a new Suzuki vehicle at a participating dealership.

### **Please note:**

- Only participants who complete all three steps within the campaign period will qualify to redeem a voucher.
- Only one entry per person will be accepted. Multiple entries will result in disqualification.
- Entries must be complete and valid to be eligible for voucher redemption.

### **WINNER SELECTION AND PRIZE**

- Participants who meet all entry requirements and are verified by the dealership will receive a voucher valued between R500 and R2,500.
- Voucher values are awarded at the discretion of the Promoter.
- The prize is non-transferable and cannot be exchanged for cash or other alternatives.

- Qualified participants will be contacted using the contact details provided during entry and must respond within 7 working days to claim their voucher.
- Failure to respond or provide proof of eligibility may result in the forfeiture of the prize, and the Promoter reserves the right to reallocate the voucher.

#### **VOUCHER ISSUANCE AND TIMING**

- Vouchers will not be issued on the day of purchase.
- At the end of each month, the Promoter will receive and verify sales data from dealerships.
- After verification, eligible winners will be contacted within 10 working days.
- This process ensures the integrity of the competition through accurate validation.

#### **EMAIL ADDRESS AS UNIQUE IDENTIFIER**

- The email address used when playing the Drop & Catch game will serve as the unique identifier for prize verification.
- This email must match the one used by the dealership when processing the vehicle sale.
- If the email addresses do not match, the entry will be invalid, and the voucher will not be issued.

#### **PARTICIPATION**

- By entering the competition, participants agree to these terms and consent to be contacted by the Promoter for competition-related communication.
- Participants consent to the use of their name and image for promotional purposes, subject to their approval.

#### **PERSONAL DATA**

- All personal data will be processed solely for the purpose of administering the competition and distributing vouchers.
- The Promoter complies with all applicable South African data protection laws and will not share data with third parties without consent.

#### **OWNERSHIP AND PUBLICITY**

- Entrants grant the Promoter permission to use their name, likeness, and entry for marketing purposes without further compensation.
- Winners may be featured in future promotional content, subject to consent.
